State of the City Address

Sky Valley Mayor Bob MacNair reported that the City Council in January began holding workshops a week before regular meetings to discuss upcoming agenda items. Citizens are invited to attend, listen to Council members discuss agenda items, and comment after each item.

Recent discussions have included the possibility of attracting a hotel, convention center or assisted living center to the city but the Council first wants to develop a comprehensive land use plan.

The council also has investigated the possibility of installing sewer service in the valley but the City first needs a developer to pay for the system. The mayor stated that Sky Valley is an "untouched jewel of Georgia."

The mayor answered three audience questions:

- What is the status of the Service Delivery Strategy between Sky Valley and Rabun County? The disagreement only affects the city's payments to the Scaly Mountain Fire Department (\$58,000/year) and the landfill fee (\$10,000/year). City Council has asked their attorney to write a letter to Rabun County Council asking for relief of those expenses.
- What is the water quality status in Sky Valley? The city has retested the water and the quality is all right. City water quality is tested four times per week.
- When will the cell phone tower be installed? It was installed last year.
