Treasurer's Report (Morley)

- \$31,673 in checking account end of May (before Welcome Back dinner)
- Welcome Back dinner expense \$5,305 / revenue \$1,740
- Authorize signatories for checks: Morley, Mason, Steil, Curtis (each one must sign a card at Regions Bank)
 - Unanimous: motion by Darrah/second by Kobacker

Welcome Back party report (Curtis for Guess)

- 164 people attended
 - o 151 members
 - o 11 guests
 - o 2 comp meals for Reeves Hardware for providing door prizes
- 170 seats reserved by the deadline \rightarrow 170 meals billed but only 164 attended
 - o -17 no-shows
 - +9 seats reserved after the deadline
 - +8 attendees without reservations
 - -6 cancellations after the deadline
- Mason contact no-shows and request payment

Membership update (Maus)

- 307 memberships (individual and family)
 - o 24 new memberships
 - o 57 memberships dropped from last year
 - o 93 memberships dropped over past 2 years
- Maus and Kobacker contact new homeowners and invite to join
 - o Volunteers help contact prospective members: Mason, Darrah, Steil and Curtis

Pancake Breakfast report (Morley)

- \$1,075 profit from May and June breakfasts
- Next breakfast is July 6

Request to fund hog trap (Mason)

- Country Club asked to split \$3,800 cost of a second hog trap and donate trap to the City to reduce damage by wild pigs
- After discussion, Board agreed to pay 50% of purchase price
 - o Unanimous: motion by Kobacker/second by Steil

CPR training (Sky Valley Police Officer Ron Baumes)

- Kay Sherburne from Sky Valley-Scaly Mountain Volunteer Fire Department will offer 4-hour "Friends & Family" training at Timeshares conference room on July 11 and 12
- Mason will circulate a sign-up sheet at general meeting and ask Maureen Platt to coordinate
- Steil will request information on AED locations and how to use the equipment

Update on July 4 events (Mason)

- Need 8 volunteers to set up before and 6 volunteers to clean up after the July 5 BBQ
 - Mason will circulate sign-up sheet at general meeting

Bylaws revision (Mason)

- Asked for opinions on allowing non-property owners to join. After discussion, board confirmed that membership is open only to property owners in Sky Valley and adjoining mountain communities. No change to bylaws was required.
- Mason will convey information to requesting party.

Membership directory advertising sales (Curtis for Guess)

- All 2020 directory ads must be sold by October 1
- Each board member is expected to contact 10 advertisers
 - o Turn in signed contracts, payment and ad materials to Guess by October 1
 - o Curtis will contact board members to sign up for advertiser assignments

Marketing update (Mason)

- Mason will contact City officials and request that Joint Marketing Committee members be appointed by the City
- SVPOA will not provide any 2019 funding to Joint Marketing Committee until a plan is developed and approved
- SVPOA may request a refund of 2018 marketing contribution due to lack of marketing activity by the City
 - Unanimous: motion by Curtis/second by Morley

New Business

- Ed Steil will contact AARP to schedule a safe driver class in Sky Valley this fall (late August or early September)
 - Need a minimum of 15 participants
 - Unanimous: motion by Morley/second by Kobacker
